NEW WORKERS' COMP ANNUAL PAYROLL REPORT PROCESS

California State PTA, in conjunction with our insurance broker Association Insurance Management (AIM), recently launched a new Workers' Compensation Annual Payroll Report Form and submission process.

This year there is **an updated report form** that is simpler and easier to complete, a **new, completely online submission process**, and you must now **send reports directly to AIM,** not your council or district PTA.



On the <u>insurance page</u> of the California State PTA website (under the heading "New Workers' Comp Annual Payroll Report Process") you'll find full details of the new process, including links to the <u>online report form</u>, links to paper forms (in English and Spanish), and documents which provide step-by-step instructions on how to fill out the forms.

INSURANCE PREMIUMS ARE DUE NOW

Just a reminder that your unit insurance premiums are due now, through channels. The premium amount for units is \$258, and for councils is \$178. Contact your Council or <u>District</u> leadership if you have any questions about this remittance.

Continuous insurance coverage, whether or not you are holding in-person PTA events, is crucial to protect your association and your leaders. That is why insurance is required in order to be a PTA in good standing. Thank you to those who have already taken care of this task. For the rest, be sure to take care of this before taking time off for the holidays.

MID-YEAR AUDIT REMINDER

Don't forget that all units, councils and districts are required to perform a mid-year audit. For the majority of PTA entities the audit period is July 1-December 31, 2020.

Please review the processes and procedures for completing this audit, which can be found in the <u>Toolkit</u>. When you're done, don't forget to upload your completed audits to <u>MyPTEZ</u>.

TEACHERS MATTER DEADLINE

The deadline for the annual Teachers Matter membership challenge is approaching! Teachers Matter is checkpoint #4 on the 2020-21 Membership Drive.

Here's a reminder of how Teachers Matter works: Any PTA that signs up 100% of its full-time credentialed teachers as members and submits a completed Teachers Matter application form by January 31, 2021 will be entered into a drawing to win a PTA tablecloth for your school.

- Remit manual and all non-TOTEM electronic memberships through proper channels.
- Attend and report results at association meeting (virtual or otherwise). Ask for program ideas.
- Send out monthly membership emails and social media posts asking community to join.
- Check your map. Meet with your Membership Committee to review your progress towards your goal.

The application form will be available on the <u>Membership Incentives webpage</u> in early January, and must be submitted by 5:00 p.m. on January 31, 2021.



SCHOOL REOPENING GUIDANCE

A few months ago we circulated a couple of reports that provide helpful guidance on the issue of school re-openings. We wanted to draw your attention to these documents once again, as many of you may be facing a new round of school reopenings in January.





The second document, by Policy Analysis for California Education (PACE) in cooperation with California State PTA, is called "Navigating the Uncertainty of Reopening Schools: A Guide for Parents, Families and the Public." This report summarizes the current state of knowledge about key issues, and suggests a set of questions that parents and educators should ask when considering plans for reopening during the pandemic. It is accompanied by this summary-infographic, which serves as a valuable handout for community discussions.
