PTA "TIME OUTS"

We have been asked several times over the past few weeks "Can I put our PTA on 'time out'?"

At first we were confused by what these units were asking, but after a few conversations we came to understand. These leaders were asking if they could basically put all PTA functions on hold for the upcoming school year. There really isn't a simple answer.

While we are not on campus, PTA can and should still provide support to our families, teachers and community. We are still planning programs, providing much needed supplies and most importantly, being a source of communicating and connection. During these uncharted times, your council, district and CAPTA are here to help you as your PTA leads the charge to promote families connecting with other families. Membership in PTA supports the partnership between school and families, which is more important than ever.

Yes, you can put some aspects of your PTA on hold, but not all. You can put fundraising and many of the programs that you usually host on campus on hold.

Last year's normal end-of-year tasks will still need to be completed. Taxes, audits and annual financial reports have due dates.

For the current year, you still need to have the three required officers (president, secretary, and treasurer), host a membership drive, and pay your yearly insurance premium. Your PTA is covered for more things than just an accident at an event.

Several of our Virtual Summer Leadership Academy workshops provided ideas to stay connected with your parents. In July, we presented two social media classes and "Engaged Families are the Key to Students' Success!" Both are available as recordings to registered attendees. Coming up in session 3 in August is a workshop on "Family Engagement During COVID-19", a class on supporting your children, and another on distance-learning platforms.

SUMMER FINANCIAL CHECKLIST

Summer is the perfect time to get the financial records for your PTA in order to close out the fiscal year. The end of year audit, one of the compliance items required from all Units, Councils and Districts, should be conducted right after the end of your fiscal year. For most of our entities that is June 30th. Please practice safe distancing and hand over of the documents needed from the treasurer to the auditor.

Once the audit is complete, the treasurer should compile the end-of-year Annual Financial Report. Another compliance document that shows a budget to actuals for the fiscal year we just completed.



Next, it is time to file the PTA taxes. Every nonprofit entity in California is required to file a form 990, 990EZ or 990N with the Internal Revenue Service, a form 199 or 199N with the Franchise Tax Board, and the RRF-1 with the California Attorney General's Registry of Charitable Trusts. In addition, there is a new form from the Attorney General: the CT-TR-1, which is also required for some units. Don't forget the bank: When you are taking care of all those other financial summer tasks, keep in mind you may also need to make changes to the signature cards at the PTA bank. In these difficult times, it is more important than ever to contact your branch to make sure you have all the proper documentation you need to update the check signers. You will also need to confirm hours of operation and the procedure they are using to allow members to visit the branch and make changes to accounts.

ELECTIONS AND MYPTEZ UPDATES

Have you held your elections yet for the 2020-21 School Year? If not, please make arrangements with your Council or District to hold that meeting virtually as soon as possible. PTA Units and Councils cannot function after the end of the term without electing new officers. A few months ago, California State PTA made the decision to allow virtual general association meetings. This is a way for our Units and Councils to continue the great work of PTA while in these very challenging times. If you have held your elections, please make sure you input the officer contact information into MyPTEZ, formerly known as PTAEZ. Inputting this information will ensure that the new leaders of your PTA receive important information over the summer months, including our Summer Service Mailing. Host a virtual "Welcome Back Social" via one of many meeting platforms available today. Invite different grade levels to attend at different times and have the teachers who will be virtually teaching those students on the call. Maybe you could have a theme like "my pets" or "my favorite book". It could be a way for everyone to talk and have some fun before the virtual school year starts.
