MORE MONEY FOR SCHOOLS NEXT YEAR? LET'S SEE.

The headlines say that California schools will get billions of dollars of new funding next year under Prop. 98, which guarantees schools about 40% of the state budget. The Legislative analyst report in November estimated the minimum Proposition 98 guarantee will increase by more than \$13 billion for the current year, 2020–21. This is because tax receipts were higher than anticipated.

This is great news, but it is only part of the financial picture.

Education is primarily a state and local responsibility in the United States. Despite only providing 10% of the funding for schools in California, the Federal government still plays an important role. From historic Supreme Court decisions to programs such as Head Start and the National School Lunch Program, national programs and policies impact the education and welfare of many of our most vulnerable students.
