THREE THINGS YOU CAN DO TO HELP OUR SCHOOLS

Education advocates are urging the Governor to protect school funding in the midst of massive state budget deficits, and taking it a step further by asking our federal representatives to include schools in the next COVID-19 relief package.

Here are three things YOU can do to help our schools:

- Contact your state representatives. Contact your elected state representatives and let them know what the impact of the Governor's proposed budget will be on your school. To find your representatives, click here.
- Advocate for more federal funding. Right now, contact your federal representatives and ask them to support an additional \$200 billion in federal funds for schools. Unless Congress acts, schools will experience major budget cuts triggered by the pandemic. Click here to send a message to your federal representatives.
- Help pass the <u>Schools and Communities First</u> initiative, which is on the November ballot. This could raise about \$11.5 billion each year for our schools and communities. Click here to volunteer.

THE 2020 CENSUS: WHY PARTICIPATE?

California has a census response rate as of May 11th of only 59.8%. For those who have not responded online to the Census, door-to-door census-taking will take place from May 27-August 14.

The 2020 Census will determine how many congressional representatives each state gets, affect hundreds of billions in federal funding every year, and provide data that will impact communities for the next decade.

Census data informs planning and funding for education, school lunches, highway construction, public transit systems, employment and training, hospitals, clinics, community mental health services, healthcare and much, much more.

PTA SUPPORTS SB 855

California State PTA has a support position on <u>SB 855 Wiener</u>. This bill requires insurance companies to provide additional care to individuals and children suffering from mental health or substance abuse issues. It also expands the criteria for what mental health issues are covered under health insurance policies.

This bill would require a health care service plan contract that provides hospital, medical, or surgical coverage to provide coverage for the diagnosis and for the *medically necessary treatment* of mental health and substance use disorders under the same terms and conditions applied to other medical conditions. The bill would prohibit a health care service plan or health disability insurer from limiting benefits or coverage for chronic or pervasive mental health and substance use disorders to short-term or acute treatment. The bill would revise the covered benefits to include basic health care services, intermediate services, and prescription drugs.

Historically insurance plans have not covered many services for mental health (MH) and substance use disorders (SUD). Many times, patients were covered for acute hospitalization but no other type of MD/SUD services. Under SB 855, MH/SUD services are defined as "medically necessary treatment". MH/SUD are treated as covered services that align with what is recommended by the treating provider, to meet the patient's comprehensive needs, and consistent with generally accepted standards of practice. What this means is, if your child or youth needs treatment prescribed by a physician, the insurance must cover the treatment as long as it is within the accepted standard of care.

This bill also prohibits limiting benefits or coverage for chronic conditions to short-term or acute treatment.

Part of our legislation platform calls for measures to extend and improve physical and mental health services and facilities, including rehabilitation to children and youth. We took a support position on this bill because we believe it will result in a significant improvement of mental health services for California's youth.

SB 855 is being heard in the Senate Health committee this month, which seems especially appropriate as May is Mental Health Awareness month. Use these links for more information and support for MH/SUD issues.
