Voting by Mail is the Safe, Secure, and Easy Option in 2020

Email Content:

Your health is important and so is your vote. Luckily, every registered voter in California can vote by mail from the safety of your home in 2020.

Instead of going to the polls on Election Day, you can vote using the vote-by-mail ballot that will be sent to you automatically in early October. After you have voted, insert your ballot in the envelope provided, making sure you complete all required information on the envelope.

You may return your voted ballot by

1. Sticking it in the mail; Vote-by-mail ballots that are mailed must be postmarked on or before Election Day and received by your county elections office no later than 17 days after Election Day.
2. Returning it in person to a polling place or the office of your [county elections official](#) no later than the close of polls at 8:00 p.m. on Election Day.
3. Dropping your ballot into one of your county's ballot drop boxes no later than the close of polls at 8:00 p.m. on Election Day.
4. Authorizing someone to return the ballot on your behalf. Anyone may return your ballot for you, as long as they do not get paid on a per ballot basis. In order for your ballot to be counted, you must fill out the authorization section found on the outside of your ballot envelope.

Facebook/Instagram Posts:

Vote by Mail is an automatic, safe, and secure option this year in California. You will automatically receive a ballot in the mail in early October. Be sure to cast your vote, seal and sign the envelope then return it by mail, deliver to your polling place, put it in a ballot drop off location or authorize someone to return your ballot on your behalf.

Did you know you have 4 options to return your ballot this year?

1. Mail it in by November 3; must be postmarked November 3 to count
2. Personally deliver it to a polling place/voting center or your [County Election Official](#)'s office by 8pm on November 3
3. Personally drop it off to one of your county's drop off locations
4. Authorize someone you trust to return your ballot on your behalf; you will need to fill out the authorization section on the outside of your ballot envelope.

Contact your county elections official for the locations of your voting centers and drop off locations.
